



### **Waiver of Liability**

Please read this form carefully and be aware that in signing up and participating in all TSS program(s) you will be waiving and releasing all claims for injuries you or the participants might sustain arising out of these programs.

"As a participant or guardian of a participant in this, or any future programs, I/we recognize and acknowledge that there are certain risks of physical injury and agree to assume the full risk of any injuries, including death, damages or losses which the participant(s) may sustain as a result of participating in any and all activities connected with or associated with such programs."

### **Medical Authorization**

The participant authorizes any representative of Triangle Swim School to have the participant treated in any medical emergency during their participation in the program. Further, the participant and/or parent/guardian agrees to pay all costs associated with medical care and transportation for the participant.

### **Pictures and Videos**

On occasion, TSS will have photographers and/or videographers come to photograph/video our students in swim classes or sponsored events. The photographs/videos may be used in advertising, on our web site, in our scrapbooks, etc. **Names of children will not be used.**

### **Payment and Policy Information**

#### **PAYMENT POLICY**

Payments for classes are due at the time of registration. This enables us to keep a more accurate record of how many students are enrolled for each class without overbooking classes.

Tuition is not prorated for absences. Please see the Make-Up Policy below.

In the event that the class time slot cannot be filled, The Triangle Swim School reserves the right to either adjust the cost of the class to correspond to the appropriate class size or cancel the class all together.

#### **REGISTRATION FEE**

There is a \$20 registration fee for the first student of each family with \$7 for each additional student, that is also to be paid when you enroll and must be renewed every calendar year. This non-refundable fee covers the cost of registering and maintaining your family in our records.

#### **FAMILY DISCOUNT**

There is a 20% discount on tuition for families with 3 or more students registered in the same session.

#### **MAKE-UP POLICY**

Because we have to reserve pool space in advance and have high operational costs, no refunds, no credits, no transfers, and no make-ups are issued for illnesses, recitals, vacations, etc. In order to maintain our small student teacher ratios we do not provide make-ups, so please choose carefully when selecting your class time.

#### WEATHER AND EMERGENCY CLOSING POLICY

In the event of a weather emergency (i.e., snowstorm, hurricane), a notification of weather related class cancellations will be posted on our website and recorded on the voicemail of the main number to the Triangle Swim School. We will be in contact with the facilities that we rent from, such as the Triangle Aquatic Center, to determine whether to delay or cancel classes.

In the event of an incident in the pool such as "vomit" or "poop" the pool will be closed for a minimum of 4 hours (or as determined by the facility) and all classes will be canceled. Because of the difficulties with getting pool space at the Triangle Aquatic Center and our other facilities, if classes are canceled because of weather or a pool closure we will issue a class credit equal to the amount of your current class to be used toward a future class session.

#### REFUND POLICY

The registration fee is non-refundable. Full refunds (less the registration fee and an administrative fee of \$25) will be given to those who cancel the entire swim session via email at least 7 days prior to the first class of the session. No refunds will be issued for any classes after 7 days prior to the first scheduled class of the session. We do not refund for missed classes for any reason.
